CIRCULAR

SUB: ANTI-RAGGING UNDERTAKING & COMPLIANCE FOR SUBMISSION BY NEW STUDENTS & UNIVERSITY.

1. As per the guidelines received from Ministry of Education (UGC) that it is mandatory to fill "Online" undertaking in respect of students admitted in academic year 2025-26. Non compliance of the instructions mentioned in succeeding paragraphs will render the admission invalid.
2. As per the revised procedure, all students are required to fill the "Online Anti-Ragging Undertaking" and the university is required to submit the "Anti-Ragging Compliance form" on the designated portal. Kindly ensure the following steps are strictly followed during "Admission Procedure":-
 - (a) **Submission of Student's Undertaking.** All newly admitted students must fill the "Online Anti-Ragging Undertaking" using the link:
https://antiragging.in/affidavit_registration_disclaimer.html
 - (b) **Submission of University Compliance.** The university will submit the "Anti-Ragging Compliance Form" using the link:
https://antiragging.in/compliance_desclaimer.html
 - (c) **Display of Anti-Ragging Posters.** Soft copies of the Anti-Ragging Posters are enclosed. Anti Ragging Committee is directed to ensure that all the posters related to "Anti Ragging are displayed in the campus including admission offices, notice boards, hostels and common areas.
 - (d) **Strict Compliance.** The admission team is directed to incorporate the above steps in the admission process/procedure and ensure compliance as per the UGC guidelines without any deviation. After obtaining the "Anti-Ragging Undertaking Number" by submitting the Anti Ragging Undertaking form, the number generated must be entered in the admission form.

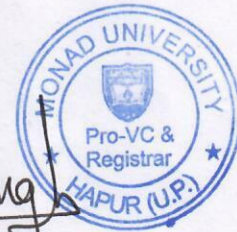
3. Submission of "Students Anti Ragging Undertaking Form" is mandatory. The admission of the students will be deemed invalid without the "Anti-Ragging Undertaking Number". All admission team heads will ensure compliance in respect of the students admitted by their team members.

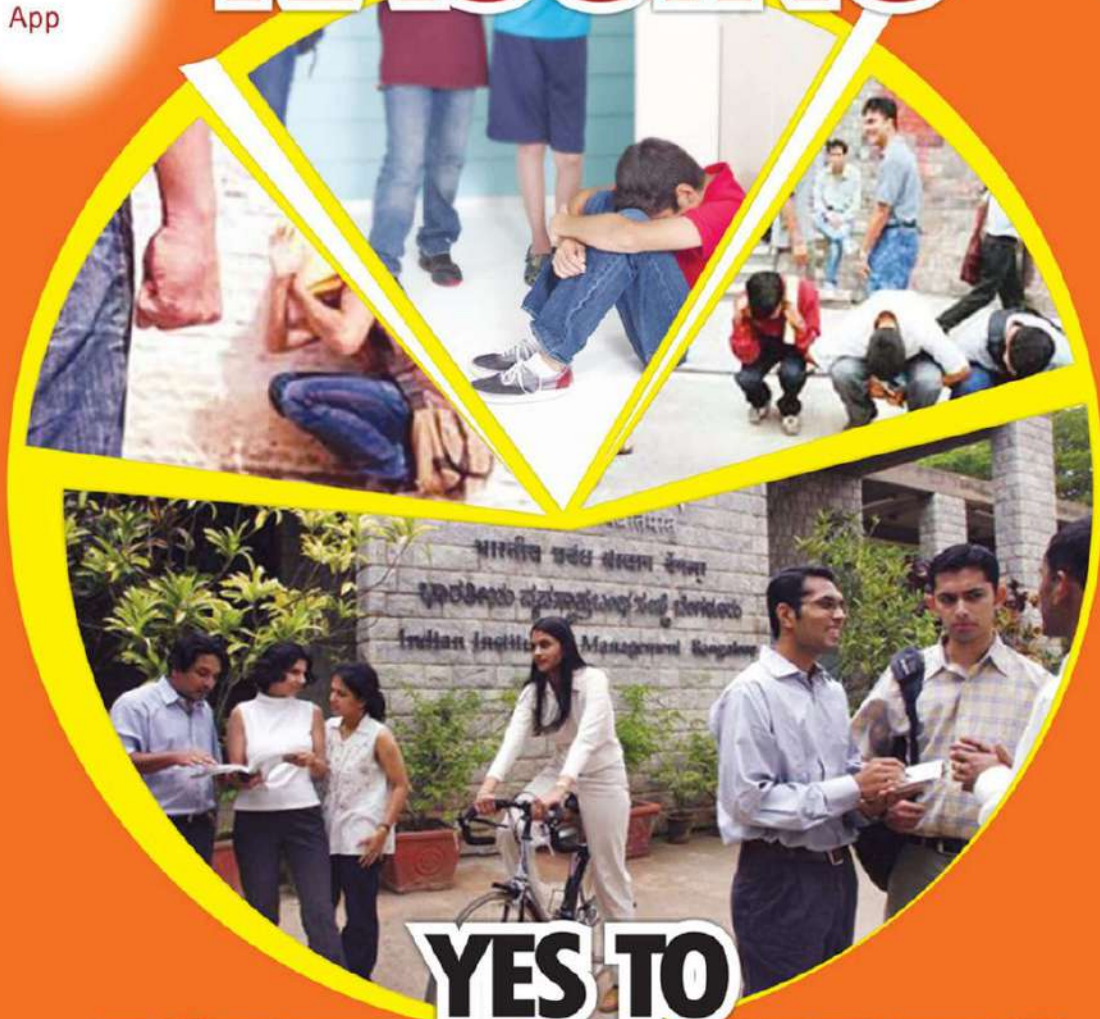

What is Ragging?

Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

A STUDENT INDULGING IN RAGGING CAN LEAD TO :

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.

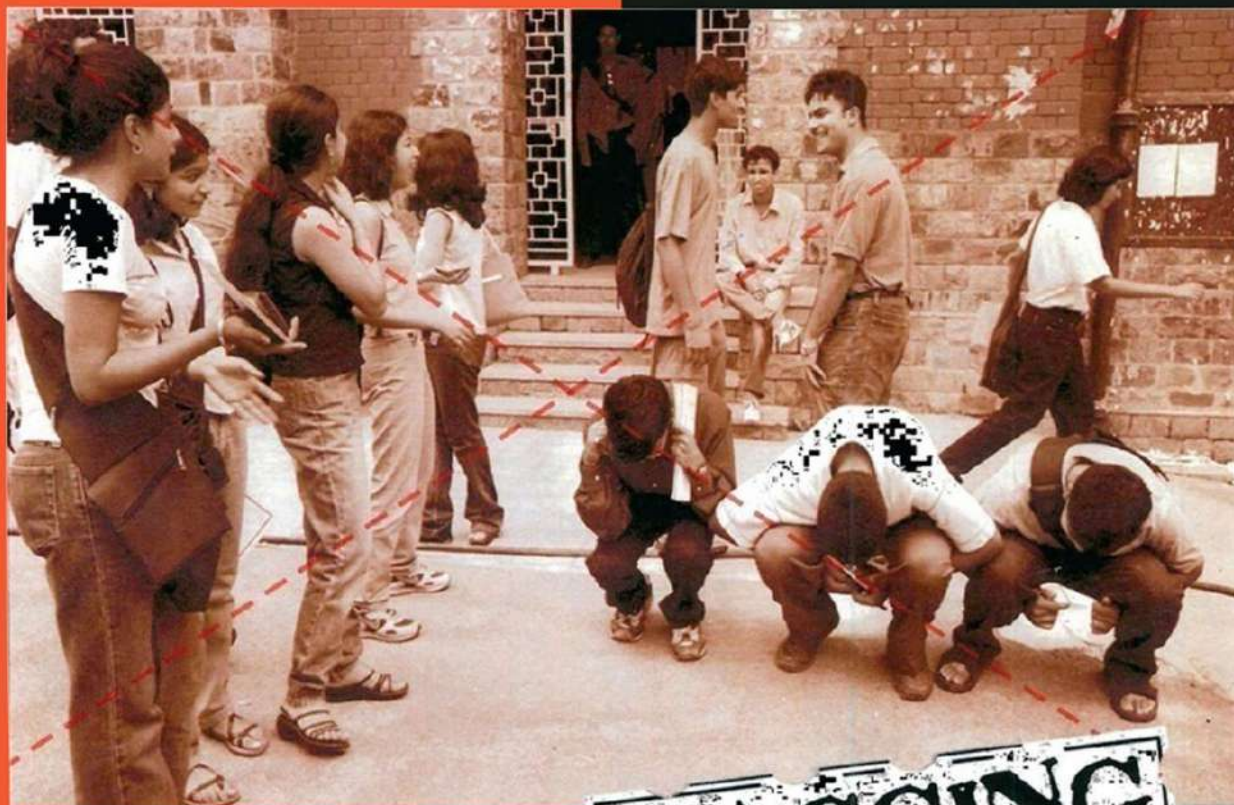
