III dated on 14 Dec, 2023 as well as the provision of any law for the time being in force concerning ragging; and also to mentor and oversee the prevention of ragging in the university.

3. It is once again reiterated that for the benefit of all the stakeholders that ragging is a criminal offence and the perpetrators/ culprits will attract punitive action as per the UGC regulations mentioned above.
